#### E K Campbell Award

This award is given to a University Professor that has excelled in Education and/or Research. This year it was awarded to our own **Dr. Jeffrey Spitler** for his work at Oklahoma State University. The award was presented at the Plenary session and an honorarium of \$10,000 presented at the Life Members Luncheon during the past winter meeting. This award is sponsored by the ASHRAE Life Members Club and is given to only one member per year, which is the reason why it is considered the highest honor received by an educator/researcher in the HVAC field. Dr. Spitler is the second member of this Chapter to receive the award, **Dr. Faye C. McQuiston** received it in 1986.

#### Central Oklahoma Chapter Hall of Fame

Our own Hall of Fame was established in 1992 by the Board of Governors with the first and only member inducted that year being **William J. Collins Jr.** From 1993 to the year 2000 the Chapter added 13 more members to the list. Most of these members were instrumental in making our Chapter the envy of most Chapters in Society culminating with the Number One spot in Society in 1993.
