The Overachiever-Mr. I.D. Nease **Historian Message**

Once every decade or so we encounter an individual who is in the top 1% of achievers. I found one the other day. Mr. I.D. Nease was an ASHRAE Central Oklahoma chapter member for many years. He was a salesman representing McQuay in the 1970s, then he worked in sales at Governair in the 1980s. When Wayne Smith (who was president of Governair at the time) was elected Central Oklahoma Chapter president for the 1982-83 chapter year, Wayne asked I.D. Nease to be Membership Chairman.

That year the regional membership chairman asked his chapter membership chairmen to endeavor to increase their membership rolls by a "net gain of 5%" for the year. Our chapter membership must have been approximately 420 at the time, because I.D. calculated that we would need 21 new members to meet this goal. What were his results for the year? As you can see from the attached scan of his report written in April, 1983, he signed up 137 new members, 94 student members, and processed 41 advancements!

Since I did not know I.D. Nease, I talked to a few senior chapter members who did know him. I was told that he was a salesman; that he contacted every company to ask a company leader who should be a member of ASHRAE, then contacted the individuals. He contacted engineering houses, contractors, vendors, utilities, hospitals, state agencies, and even accountants and others normally outside our industry. He thought outside the box. And most of his new members were signed up before the first chapter meeting of the year!

Activities of the Membership Committee

Central Oklahoma's Membership goals are set to coincide with the Regional goals of an increase in net growth of 5% (21 net new members) and with extra emphasis on upgrading membership

Our student members are recruited by Dr. McQuiston on the O.S.U. campus and by Dr. Turkington on the O.U. campus and by Phil Condreay on the O.S.U.T.I. campus. Thus far this year ninety-four (94) student applications were forwarded to Society.

Forty one (41) member applications forwarded for upgrading to full member.

One hundred thirty seven (137) new member applications have been forwarded to Society thus far this year. This will make our goal achievable with the net growth figures.

As of April 1, 1983 the Membership chairman has processed a total of 272 applications.

What about all those new members? Did they stick around? Some may not have stayed for many years. But others did, and are pillars in our industry. I found four on his new member list who later became chapter presidents - Bruce Albertson, Chuck Darr, Brad Binning, and Pete Ray.

I'm quite sure that Wayne Smith gave his employee I.D. Nease special permission to devote extra time to ASHRAE. Nease writes in a report in 1983, "...the above was accomplished by the goodwill and generosity of Governair Corporation plus my two cents worth." I.D. died in January of 2001 at the age of 83. We thank you, I.D. Nease, for your "two cents" in contributing to our chapter and our industry.

The natural application for each of us present-day members is to look around our organizations and those with whom we interact, and ask "Have you thought about becoming an ASHRAE member?" Just your own story of benefiting from ASHRAE may be all that's necessary in helping recruit a future leader in our chapter and industry.
